UPDATE – 2016-17 CALENDAR

Last year, SDTA and the district negotiated calendars for both this year and next. Next year's

calendar was complex because of when the Winter Holidays fell and trying to be respectful of students' and employees' potential needs to travel to see family and also preserving our members' desire not to start the year in the second week of August.

Based on feedback from our members after the professional development days this past August, though, it became clear to both the Professional Development department and to SDTA that teachers are not able to focus entirely on PD training while simultaneously planning out their entire year and getting settled into, often, new physical spaces. With that in mind, at the Legislative Council discussed a proposal from the District to move around the placement of the PD days in 2016-2017 and made a counterproposal which was approved by the Board this week.

The full calendar is reprinted on the back of this Hotline, but it is important to note that the actual work days have NOT been changed, we have only reassigned some of the PD days to respond to the input that our members gave. In summary, one PD day has been moved from August 16 to January 10th, with a site PD day following it on January 11th. The October PD day was also moved earlier in the year, to September 19th.

While these don't change our work days, they do mean that the first day of classes is moved up one day to Wednesday, August 16th (and an additional instructional day is shifted from the second to the first semester) and the first day of classes for second semester is pushed back to Thursday, January 12th.

Nothing about next year's calendar is "ideal", but hopefully these changes will make the professional development days more meaningful for all of us.
