SDTA BACK AT THE TABLE

In the last round of bargaining, SDTA and the District settled a 2-year contract, with limited “reopeners”, and thus we are back at the table to negotiate the areas of salary, health and welfare benefits (the District’s chosen “reopener”) and class size (SDTA’s chosen “reopener”). The sides met on March 20th to exchange initial proposals and discuss their implications.

While neither side has proposed any specific numbers on salary, SDTA has proposed aligning increases bargained to salary to Schedule B (curriculum rate) and adjusting stipend amounts and allocations in Schedule C (coaching and activities stipends). In the area of class size, SDTA has reiterated its proposals to establish a contractual staffing ratio for RSP special ed teachers, psychologists, and school nurses, to create caseload limits for STARS, ILS, and TRACE teachers, to establish a total enrollment cap for instrumental music and chorus teachers (who are currently exempted from any enrollment caps), to add two case management release days for ILS and TRACE teachers, and finally to establish that

Department Chair positions will be appointed as the result of secret ballot elections among department members.

The District’s proposal echoes one they brought up late in the process last round that involved capping the District’s contribution toward health benefits at the cost of the premiums for the Kaiser and HealthNet plans offered by CalPERS. The District proposal calls for the difference in cost to be applied to the salary schedule. This would require our members on Blue Shield, or any of the PPO plans where the premiums exceed the Kaiser/HealthNet cost to either choose a new plan or to pay the difference out of pocket. This out-of-pocket amount is likely considerably higher than the savings that would be applied to the salary schedule.

Negotiations resume April 26th with additional dates planned May 9th and 12th.

SDTA ELECTIONS COMING UP

Elections for site reps and our delegate to CTA’s State Council will be held April 19-21. For the first time ever, SDTA will be using online balloting for our internal elections, which is why you have received (in some cases numerous) requests for your personal, non-district email address.

If we have your personal email address, you will receive an email at that address on April 19th with directions about how to log-in to your ballot and vote. You will have until 11:59 on April 21st to complete your ballot.

If we do not have your personal email address, you will receive a paper ballot in your school mailbox with directions for returning it to the SDTA Office when you have completed it. The timeline will be the same.
