As you've heard on the news or at site meetings, the US Supreme Court is currently considering a case, Janus vs. AFSCME, that could have a lasting effect on unions throughout the country. Like its predecessor, Friedrichs vs. CTA, this case challenges the concept of agency fee and argues that bargaining unit members who benefit from the terms and protections of a collectively bargained contract should have no responsibility to support the work that goes into negotiating and maintaining that contract. If the Court returns a decision that eliminates agency fee and negates current memberships, SDTA will be looking to you, our members, to keep us strong. Thank you to those of you who have already completed commitment cards declaring your promise to re-join SDTA if the need arises. If you haven't signed one yet, please get in touch with a site rep to do sign up.

Through our unity, we maintain our strength.

BARGAINING UPDATE

Bargaining Proposals have been exchanged between the District and SDTA. During three bargaining sessions, the sides have discussed their proposals and asked and answered questions about them.

The District's on-the-record proposal continues to seek a cap to District-provided benefits at the level of the Kaiser premium, in return for which they are offering a 1% raise. In addition, they are interested in creating a professional development committee as well as an agreement to meet and confer regarding issues that may arise during the continued development of TIDE Academy. The District's original proposal mentions an interest in "preserving instructional time with students' regular teachers" which continues into their current on-the-record proposal, but there has been no further discussion of what form the District feels that might take.

The teams return to the bargaining table on April 5 with four more dates scheduled.

CALIFORNIA JUNE PRIMARY

CTA has endorsed **Gavin Newsom for Governor of California** and **Tony Thurmond for State Superintendent of Public Instruction**. With the unknown future that awaits us in a post-Janus world, it is crucial that we elect pro-education, prounion leaders in Sacramento.
